SUBSIDIARY LEGISLATION

ORDINANCE 19 OF 1961.

AN ORDINANCE

TO AMEND THE GAME AND WILD BIRDS ORDINANCE.

ADMINISTRATOR.

BE it enacted by the Administrator of the Sovereign Base Areas as follows:-

1. This Ordinance may be cited as the Game and Wild Birds (Amendment) Ordinance, 1961, and shall be read as one with the Game and Wild Birds Ordinance (hereinafter referred to as the "principal Ordinance").

Short title.

Cap. 65 (Laws of Cyprus).

2. Section 16 of the principal Ordinance is hereby amended by the insertion, after sub-section (1), of the following sub-section:-

Section 16 of the principal Ordinance amended.

"(1A) The Administrator may by order published in the Gazette add to, or delete from, the list of wild birds referred to in sub-section (1) of this section."

Section 19 of the principal Ordinance amended.

3. Section 19 of the principal Ordinance is hereby amended by deleting proviso (a) to sub-section (1) thereof.

Ordinance 20 of 1961.

AN ORDINANCE

To Amend the Offenders Removal and Detention Ordinance.

BE it enacted by the Administrator of the Sovereign Base Areas as follows:-

Short title.

Ordinance 7 of 1960.

- 1. This Ordinance may be cited as the Offenders Removal and Detention (Amendment) Ordinance, 1961, and shall be read as one with the Offenders Removal and Detention Ordinance, 1960, (hereinafter referred to as "the principal Ordinance").
- New Section 5 inserted in the principal Ordinance.
- 2. The principal Ordinance is hereby amended by inserting immediately after Section 4 thereof the following new section, to be numbered 5:-

"Conveyance by air of persons in custody from one part of the Areas to another. 5. Where any person is in legal custody in any place within one of the Areas and such person is required to be removed in custody to another place within the other Area, he shall, if removed by air in an aircraft belonging to, or chartered by or on behalf of, Her Majesty, be deemed to continue in legal custody until he reaches the place to which he is required to be removed."

AN ORDINANCE

To Provide for the Courts of the Sovereign Base Areas of Akrotiri and Dhekelia Exercising jurisdiction under the Fugitive Offenders Act, 1881.

BE it enacted by the Administrator of the Sovereign Base Areas as follows:-

1. This Ordinance may be cited as the Fugitive Offenders (Jurisdiction of Courts) Ordinance, 1961.

Short title.

2. In this Ordinance, unless the context otherwise requires:-

Interpretation.

"Act" means the Fugitive Offenders Act, 1881;

"Judge's Court" means the Judge's Court as described in the Courts Ordinances, 1960 and 1961;

Ordinances 3 of 1960 and 7 of 1961.

"Senior Judge's Court" means the Senior Judge's Court as described in the Courts Ordinances, 1960 and 1961.

3. (1) The jurisdiction under Part One of the Act to hear a case and commit a fugitive to prison to await his return in the manner provided by the Act, to the part of Her Majesty's Dominions from which he is a fugitive, shall be exercised in the Areas by the Judge's Court.

Jurisdiction of Judge's Court and Senior Judge's Court under the Act.

(2) The Senior Judge's Court shall be deemed to be a superior court as defined in Section 39 of the Act.

ORDINANCE 22 OF 1961.

AN ORDINANCE

TO AMEND THE DOGS ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas as follows:

1. This Ordinance may be cited as the Dogs (Amendment) Ordinance, 1961, and shall be read as one with the Dogs Ordinance (hereinafter referred to as the "principal Ordinance").

Short title.

Cap. 52 (Laws of Cyprus.). Section 2 of the principal Ordinance amended.

- 2. Section 2 of the principal Ordinance is hereby amended by deleting the definition of "appropriate authority" appearing therein and substituting therefor the following new definition:-
 - " 'appropriate authority' means any Area Inspector or any such other person as may be appointed or authorised by the Chief Officer."

Section 7 of the principal Ordinance amended.

3. Section 7 of the principal Ordinance is hereby amended by deleting in paragraphs (d), (e) and (f) thereof respectively, the words "within a municipal or improvement area".

Short title.

Cap. 96 (Laws of Cyprus).

Section 20 of the principal Ordinance amended.

- 1. This Ordinance may be cited as the Streets and Buildings Regulation (Amendment) Ordinance, 1961, and shall be read as one with the Streets and Buildings Regulation Ordinance (hereinafter referred to as the "principal Ordinance").
- 2. Section 20 of the principal Ordinance is hereby amended by deleting in the third line of sub-section (3) thereof the word "shall" and substituting therefor the word "may".
