ORDINANCE 10 OF 1966.

# AN ORDINANCE

TO AMEND THE CRIMINAL CODE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

1. This Ordinance may be cited as the Criminal Code (Amendment) Ordinance, 1966 and shall be read as one with the Criminal Code as amended from time to time, and in particular by the Criminal Code (Amendment) Ordinance, 1963 (hereinafter referred to as "the principal Ordinance").

Short title.

Cap. 154 (Laws of Cyprus), Ordinances 11 of 1963 and 17 of 1963.

2. Section 203 of the principal Ordinance is hereby amended by deleting subsection (2) thereof and substituting therefor the following new subsection:-

Section 203 of the principal Ordinance amended.

"(2) Any person convicted of premeditated murder shall be sentenced to imprisonment for life:

#### Provided that—

(i) On sentencing any person convicted of premeditated murder to imprisonment for life, the Court may at the same time declare the period which it recommends to the Administrator Cap. 286 (Laws of Cyprus). as the minimum period which in its view should elapse before the Administrator orders the release of that person on licence under section 11 of the Prison Discipline Ordinance;

- (ii) Subsection (2) of Section 27 of this Code shall apply to such sentence as if it were a sentence of death; and
- (iii) Section 29 of this Code shall not apply to such sentence".

### AN ORDINANCE

To Amend the Income Tax Ordinance.

Short title.

Cap. 323 (Laws of Cyprus and Ordinance 16 of 1961.

Section 8 of the principal Ordinance amended. BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:-

- 1. This Ordinance may be cited as the Income Tax (Amendment) Ordinance, 1966, and shall be read as one with the Income Tax Ordinance, (hereinafter referred to as "the principal Ordinance").
- 2.—(1) Section 8 of the principal Ordinance is hereby amended by inserting immediately after paragraph (f) thereof the following new paragraph to be lettered (ff):-
  - (ff) (i) The emoluments payable to members of a civilian component in respect of their employment by an authorised service organisation;
  - (ii) in this paragraph the expressions "authorised service organisation" and "civilian component" shall have the meaning ascribed to them in the definitions respectively set out in sub-paragraph (b) of paragraph 1 of Part I of Annex B and in sub-paragraph (b) of paragraph 1 of Section 1 of Annex C of the Treaty of Establishment between the

United Kingdom, Greece, Turkey and the Republic of Cyprus, signed at Nicosia on the 16th day of August, 1960;

- (iii) this paragraph shall be deemed to have come into force on the 1st day of January, 1966.
- **3.** Section 50 of the principal Ordinance is hereby amended by inserting immediately after subsection (5) thereof the following new subsection to be numbered (6):-

Section 50 of the principal Ordinance amended.

"(6) The Administrator may, by Order under this subsection, make such provision as he considers necessary for modifying any arrangements such as are mentioned in subsection (1) of this section in their application to the Areas to ensure that the arrangements do not confer any exemption which they would not have had effect to confer in the circumstances in which they applied at the time when they first had effect under the said subsection (1)."
