ORDINANCE 6 OF 1981.

AN ORDINANCE

TO AMEND THE FISHERIES ORDINANCE.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Fisheries (Amendment) Ordinance, 1981 and shall be read as one with the Fisheries Ordinance, as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.

Cap. 135 (Laws of Cyprus), Ordinances 28/1961, 3/1970 and 5/1972.

2. Section 5 of the principal Ordinance is hereby amended by deleting the words “five hundred” appearing in the penultimate line thereof and substituting therefor the words “three thousand”.

Section 5 of the principal Ordinance amended.

3. Section 6 of the principal Ordinance is hereby amended :

Section 6 of the principal Ordinance amended.

(a) by deleting the full stop at the end of paragraph (g) of subsection (2) thereof and substituting therefor a semi colon ; and

(b) by inserting immediately after paragraph (g) of subsection (2) thereof the following new paragraphs, to be lettered (h) and (i) respectively :—

“(h) provide for the imposition of fees for the grant of any licence issued under any regulations made in pursuance of this Section of the Ordinance ;

- (i) provide for the number and the terms and conditions under which fish farms may be established and operated as well as the selection of persons to whom a licence for the establishment of fish farms may be granted.”;
- (c) by deleting the words “five hundred” appearing in the fourth and seventh lines of subsection (3) thereof and substituting therefor the words “three thousand”.

ORDINANCE 7 OF 1981.

AN ORDINANCE

TO AMEND THE ANTIQUITIES ORDINANCE, 1975.

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Antiquities (Amendment) Ordinance, 1981 and shall be read as one with the Antiquities Ordinance, 1975 (hereinafter referred to as “the principal Ordinance”).

Short title.

2. Section 2 of the principal Ordinance is hereby amended by inserting immediately after Section 12 in Part II thereof the following new Section to be numbered 12A:—

12A. Ancient monuments in Limassol, Larnaca and Famagusta districts of the Republic, which are defined as such under the provisions of the Republican law and which are in the proximity of the Sovereign Base Areas, shall be treated as ancient monuments for the purposes of Sections 11 and 12 of this Ordinance.”
