ORDINANCE 3 OF 1983.

AN ORDINANCE

TO AMEND THE CIVIL PROCEDURE ORDINANCE.

ADMINISTRATOR

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Civil Procedure (Amendment) Ordinance, 1983 and shall be read as one with the Civil Procedure Ordinance, as amended from time to time (hereinafter referred to as “the principal Ordinance”).

Short title.

Cap. 6 (Laws of Cyprus), Ordinances 18/66 and 9/70.

2. Section 11 of the principal Ordinance (as amended by Section 2 of Ordinance 9 of 1970) is hereby amended by deleting the word “four” appearing in the third line of subsection (2) thereof and substituting therefor the word “six”.

AN ORDINANCE

**TO AMEND THE TERMINATION OF EMPLOYMENT
(CONSOLIDATION) ORDINANCE, 1980.**

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

Short title.

1. This Ordinance may be cited as the Termination of Employment (Consolidation) (Amendment) Ordinance, 1983 and shall be read as one with the Termination of Employment (Consolidation) Ordinance, 1980 as amended by the Termination of Employment (Consolidation) (Amendment) Ordinance, 1981 (hereinafter referred to as "the principal Ordinance").

Section 19 of

2. Section 19 of the principal Ordinance is hereby amended by deleting the first proviso to subsection (2) thereof and substituting therefor the following new proviso:—

"Provided that no contribution shall be payable in respect of any wages exceeding the maximum weekly or monthly insurable earnings prescribed from time to time under the Social Insurance (Facilitation of Republican Social Insurance Scheme) Ordinance, 1980."

Fourth Schedule
to the principal
Ordinance
amended.

3. The Fourth Schedule to the principal Ordinance is hereby amended by deleting from the proviso to paragraph 4 thereof the words "eighty four" and substituting therefor the words "one hundred and eighteen".

Commencement.

4. This Ordinance shall be deemed to have come into effect on the 4th April, 1983.
