ORDINANCE 22 OF 1989.

AN ORDINANCE

TO AMEND THE CIVIL PROCEDURE ORDINANCE

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows:—

1. This Ordinance may be cited as the Civil Procedure (Amendment) Ordinance, 1989 and shall be read as one with the Civil Procedure Ordinance, as amended from time to time (hereinafter referred to as “the principal Ordinance.”).

Short title.

Cap. 6 (Laws of Cyprus) Ordinances 18/66, 9/70 and 3/83.

2. Section 55 of the principal Ordinance is hereby amended by deleting the word “two” appearing in the second line thereof and substituting therefor the word “six”.

Section 55 of the principal Ordinance amended.

3. Section 56 of the principal Ordinance is hereby amended by deleting the words “one year” appearing in the third line of subsection (1) thereof and substituting therefor the words “two years”.

Section 56 of the principal Ordinance amended.

**TO AMEND THE CUSTOMS AND EXCISE DUTIES

BE it enacted by the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia as follows :—

Short title.

Ordinance
10 of 1989.

1. This Ordinance may be cited as the Customs and Excise Duties (Amendment) (No. 1) Ordinance, 1989 and shall be read as one with the Customs and Excise Duties Ordinance, 1989 referred to as "the principal Ordinance."

2. The Third Schedule to the principal Ordinance is hereby amended by the addition in the appropriate numerical order, of the following new classes of goods appearing in the Schedule to this Ordinance :—

**"A.—GOODS MANUFACTURED OR PRODUCED
IN THE AREAS OR THE REPUBLIC**

Class or Description of Goods	Rate of Duty
9. Motor vehicles of Tariff Heading 87.02 of the Second Schedule to the Customs and Excise Duties Ordinance which are lawfully registered under the Motor Vehicles and Road Traffic Ordinance as vehicles intended for the carriage of persons not exceeding nine in number, including the driver.	A sum equal to the difference between the import duty payable under the provisions of Tariff Heading 87.02 of the Second Schedule to the principal Ordinance and the import duty plus the Excise Duty payable for like vehicles of tariff heading 87.03.

B.—IMPORTED GOODS

Class or Description of Goods	Rate of Duty
3. Motor vehicles of Tariff Heading 87.02 of the Second Schedule to the Customs and Excise Duties Ordinance which are lawfully registered under the Motor Vehicles and Road Traffic Ordinance as vehicles intended for the carriage of persons not exceeding nine in number, including the driver.	A sum equal to the difference between the import duty payable under the provisions of Tariff Heading 87.02 of the Second Schedule to the principal Ordinance and the import duty plus the Excise Duty payable for like vehicles of tariff heading 87.03."
