**THE CONTROL (ENTRY, SETTLEMENT AND COMMERCIAL ENTERPRISES) ORDINANCE, 1960.**

**REGULATIONS MADE UNDER SECTION 23**

In exercise of the powers vested in me by Section 23 of the Control (Entry, Settlement and Commercial Enterprises) Ordinance, 1960, I hereby make the following Regulations :—

1. These Regulations may be cited as the Control (Entry, Settlement and Commercial Enterprises) (Recognised Residence) Regulations, 1960.

2. The Recognised Residents list, applications for certificates of recognised residence, certificates of recognised residence, notice of cancellation of the certificate of recognised residence, and applications for restoration of a certificate of recognised residence, shall be in the form set out in the Schedule to these Regulations.

**THE CONTROL (ENTRY, SETTLEMENT & COMMERCIAL ENTERPRISES) ORDINANCE 1960.**

**REGULATIONS MADE UNDER SECTION 23.**

William MacDonald

Administrator

In exercise of the powers vested in me by Section 23 of the Control (Entry, Settlement and Commercial Enterprises) Ordinance, 1960, I hereby make the following Regulations :—

1. These Regulations may be cited as the Control (Entry, Settlement and Commercial Enterprises (Business Licences) Regulations 1960.

Short Title

2. Applications for a Business Licence shall be in the form set out in the First Schedule to these Regulations.

Form of application

3. A Business Licence shall be in the form set out in the Second Schedule to these Regulations.

Form of Licence

4. The fee for a Business Licence shall be as in the Third Schedule to these Regulations. A Business Licence shall be issued on or after the first day of January and shall expire on the thirty-first day of December in every year. Every Business Licence shall be exhibited in a conspicuous place in the licensed premises. No Business Licence shall be transferable.

Fees

5. Any commercial or industrial enterprise which was carried on in the Areas on the 16th August, 1960, shall be exempted until the 31st December, 1960, from the provisions of Section 21 (1) of the Ordinance.

#### THE GAME AND WILD BIRDS PROTECTION ORDINANCE ORDER UNDER SECTIONS 2 AND 3.

In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Ordinance, the Administrator has been pleased to prescribe that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Ordinance.

#### SCHEDULE

1. The period between 1st October, 1960, and 22nd October, 1960, both days inclusive.
2. The period between the 16th of January, 1961, and 31st January, 1961, both days inclusive.
3. All days in the week during a non-close season except Wednesdays and Sundays, and the 26th December, 1960.
