THE INDUSTRIAL TRAINING AUTHORITY
(REPUBLIC OF CYPRUS) (RECOGNITION)
ORDINANCE, 1979.

(Ordinance No. 1 of 1979).

REGULATIONS MADE BY THE ADMINISTRATOR
UNDER SECTIONS 9 AND 15.

In exercise of the powers conferred upon him by Section 9 and 15 of the Industrial Training Authority (Republic of Cyprus) (Recognition) Ordinance, 1979 the Administrator hereby makes the following regulations :—

PART I.

Preliminary.

1. These Regulations may be cited as the Industrial Training Authority (Employers' Levy) Regulations, 1979.
2. In these Regulations, unless the context otherwise requires :—

“levy” means the levy payable by an employer to the Fund under the provisions of the Ordinance ;

“levy month” means a period of four or five weeks during which a levy is payable, beginning with the first Monday of a calendar month and ending on the Sunday prior to the first Monday of the following calendar month ;

“levy week” means a period of seven days beginning at midnight between Sunday and Monday.

PART II.

Fixing of limit of levy, manner and time of payment.

3.—(1) Every employer shall, within a month from the coming into force of these Regulations, apply on the prescribed form for registration in the employers' register kept by the Chief Officer giving his address, location of employment, the number of persons employed by him and any other information which may be required from him.

(2) Every person, who after the coming into force of these Regulations becomes an employer, shall, within a month from the date of his becoming an employer apply to be registered in the employers' register as provided in paragraph (1) of this Regulation.

(3) A registration of any employer registered under the provisions of the Annual Holidays with Pay Ordinance or under the Social Insurance Law of the Republic or the Termination of Employment Ordinance shall be regarded as a registration made for the purposes of these Regulations and any employer so registered shall be under no obligation to register in accordance with paragraph (1) of this Regulation.

4.—(1) The amount of levy payable by an employer shall be half of one *per centum* (0.5%) of the emoluments payable to each of his employees :

Provided that no levy in respect of any part of the emoluments exceeding thirty pounds for the levy week or one hundred and thirty pounds for the levy month shall be payable :

Provided further that an employer may pay into the Fund half of one *per centum* (0.5%) of his total wage bill in any levy month, excluding the emoluments payable to each employed person over the maximum limit prescribed in the first proviso of this paragraph.

(2) For the purpose of calculating the amount of levy on any commission, thirteenth month salary or any other payment counting as emoluments and relating to a longer period than the normal period of payment, such payment shall be divided by the number of levy weeks in such longer period and a levy shall be payable on the weekly amount of emoluments so calculated for each levy week within such period subject to aggregating the levies which may have previously been paid during such levy week.

5.—(1) Every employer shall keep a register of emoluments or any corresponding register in which he shall record the following particulars in respect of each person employed by him :—

- (a) the name and surname of the employed person ;
- (b) his Social Insurance number and/or his Identity Card number ;
- (c) the amount of money paid to the employed person in respect of his emoluments and the period to which such payment relates.

(2) The register of emoluments or any corresponding register shall be available for inspection at any reasonable time by an Inspector as prescribed under the Republican Law or these Regulations.

6. Every levy which an employer is liable to pay shall be paid within one month from the end of the levy month which includes the levy week in respect of which the levy is payable.

7.—(1) All the levies which an employer is liable to pay shall be paid by him at such place as may be prescribed by the Chief Officer.

(2) During each payment of levy the employer shall submit a certificate of levies in the prescribed form.

PART III.

Miscellaneous.

8. Any person who :—

- (a) fails to pay to the Fund within the time limit prescribed by Regulation 6 any levy which he is liable to pay ; or
- (b) fails to do any act or take any steps required by these Regulations,

shall be guilty of an offence and shall be liable on conviction to a fine not exceeding fifty pounds.

9. Any person who with a view to evading payment of levies, whether by himself or by some other person, knowingly or recklessly makes any false statement or representation, or produces or furnishes or causes to be produced or furnished any document or information which he knows to be false in any material particular shall be guilty of an offence and shall on conviction be liable to a fine not exceeding one hundred pounds.

10. In addition to any punishment on conviction for any of the offences in Regulations 8 and 9 the Court may direct the payment into the Fund of any levy due but unpaid in relation to the offence.

11. Where an offence under the provisions of these Regulations committed by a body corporate is proved to have been committed with the consent or connivance of, or to be attributable to any neglect on the part of, any director, manager, secretary or other similar officer of the body corporate or any person who was purporting to act in any such capacity, he as well as the body corporate, shall be guilty of that offence and shall be liable to be proceeded against and be punished accordingly.

12. These Regulations shall come into operation on the 7th May, 1979.

THE SEA BATHERS (PROTECTION) ORDINANCE, 1968

(Ordinance No. 16 of 1968).

ORDER MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Sea Bathers (Protection) Ordinance, 1968, I, the Chief Officer, hereby make the following Order :—

1. This Order may be cited as the Sea Bathers (Protection) Order, 1979.

2. The areas specified in the Schedule hereto (hereinafter referred to as "reserved areas") are reserved exclusively for persons bathing in the sea, subject to the conditions and restrictions set out in the said Schedule in respect of each area :

Provided that the restrictions relating to the sailing of boats within the reserved areas shall only have effect between sunrise and sunset.

3. The reserved areas shall be demarcated by buoys.

4. This Order shall become operative on the 14th day of May, 1979, and cease to have effect on the 31st day of October, 1979.

SCHEDULE

SOVEREIGN BASE AREA AKROTIRI

1. Tunnel Beach Episkopi.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 85603587 of Sheet 23, series K717, edition 2-GSGS, to a point under map reference 85503585; then westwards at a distance of about 100 yards from the shore for about 600 yards to a point under map reference 84943606, whence the distance from the shore increases to about 200 yards as far as a point under map reference 84443609 and then proceeds in a north westerly direction to a point under map reference 84413618 and from thence to the shore at a point under map reference 84323630.

2. Happy Valley Beach Episkopi.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 83523573 of Sheet 23, series K717, edition 2-GSGS to a point under map reference 83303562; thence westwards at a distance of about 220 yards from the shore for about 800 yards to a point under map reference 82593573 and it then proceeds westwards to the headland under map reference 82433567.

3. Paramali Beach.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 824356 of Sheet 23, series K717, edition 2 GSGS to a point under map reference 824355, a distance of 220 yards from the shore, and continuing at that distance westwards to a point under map reference 807358.

4. Evdhimou Beach.

The area of the territorial waters of the Sovereign Base Areas 40 yards to the west of the Jetty under map reference 787353 of Sheet 23, Series K717, edition 2-GSGS to a point under map reference 781353 within a distance of 75 yards from the shore as marked by buoys. The area from point 789352 to a point due south 75 yards from the shore and thence eastwards within a distance of 75 yards from the shore as marked by buoys to a point on the shore at map reference 792352.

5. Royal Air Force Station Akrotiri.

The area of the territorial waters of the Sovereign Base Areas bounded by lines opposite the eastern shore of the Akrotiri peninsula at a distance from the shore varying from 100 yards to 280 yards as marked with buoys and running in a north - westerly direction —

(a) from a point under map reference 026267 to a point under map reference 015278

and

(b) from a point under map reference 033254 to a point under map reference 031256

of Sheet 23, series K717, edition 2-GSGS :

Provided that sailing vessels and speed boats may enter the area designated at paragraph (a) above through a sea lane of an approximate width of 20 yards which shall be marked with buoys.

6. Ladies Mile Beach.

The area of the territorial waters of the Sovereign Base Areas stretching out to 150 yards from high water mark from boundary pillar No. 266 on the Sovereign Base Area boundary and extending southwards up to a point opposite the shore under map reference 010283 of Sheet 23, series K717, edition 2-GSGS :

Provided that motor launches and sailing vessels may enter the said area through two sea lanes, one of an approximate width of 50 yards and the other of an approximate width of 400 yards both of which shall be marked with buoys :

Provided further that the foreshore under this paragraph shall include land within a distance from high water mark not exceeding 10 yards.

Copies of the maps referred to above are properly marked and deposited at the Area Office of the Sovereign Base Areas Administration Akrotiri for inspection by any interested person.

SOVEREIGN BASE AREA DHEKELIA

1. Officers' Club Beach.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 67897116 of the Dhekelia map, series K912, edition 4-T-GSGS, to a point westwards under map reference 67457110 ; thence northwards to a point on the headland under map reference 67457119.

2. CESSAC (Church of England Soldiers', Sailors', Airmen's Club) Beach.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 67187143 of the Dhekelia map, series K912, edition 4-T-GSGS, then southwards to a point under map reference 67107132 and then to a point westwards on the coast under map reference 66737129.

3. St. George's Club Beach.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the headland on the east, under map reference 66367119 of the Dhekelia map, series K912, edition 4-T-GSGS to a point westwards on the headland under map reference 66097118.

4. Victory Club (Off Alexander Barracks).

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the shore under map reference 65407126 of the Dhekelia map, series K912, edition 4-T-GSGS to a point southwards under map reference 65407115; thence westwards in a straight line to a point under map reference 65297115; thence northwards to the shore to a point under map reference 65297125.

5. Charlie's Casino Beach.

The area of the territorial waters of the Sovereign Base Areas bounded by a line from the shore under map reference 643711 of Sheet 21, series K717, edition 1-GSGS to a point southwards under map reference 643710; thence westwards in a straight line to a point under map reference 641710; thence northwards to the shore to a point under map reference 641711; all of which area stretches for 300 yards along the coast and at a distance of 100 yards from high water mark.

Copies of the maps referred to above are properly marked and deposited at the Area Office of the Sovereign Base Areas Administration Dhekelia for inspection by any interested person.
