THE ANTIQUITIES ORDINANCE, 1975

(Ordinances 12 of 1975 and 7 of 1981).

NOTICE UNDER SECTION 11 READ WITH SECTION 12A

In exercise of the powers vested in him by Section 11 read with Section 12A of the Antiquities Ordinance, 1975, the Administrator hereby orders and it is hereby ordered as follows:—

From and after the date of the publication of this notice in the Gazette no building shall be erected, reconstructed or repaired and no tree shall be felled within the area adjacent to an ancient monument to wit Kolossi Castle situated in the village of Kolossi, in so far as it lies within the Sovereign Base Area of Akrotiri, comprising the plots specified in the Schedule hereto save in accordance with the terms of a permit in writing from the Area Officer previously obtained.

S C H E D U L E

All those areas of land situated in Kolossi village, Ayios Loukas Quarter, in so far as they lie within the Sovereign Base Area of Akrotiri including plots Nos. 135 (part), 136/1 (part), 136/2 (part), 137/1/1 (part), 137/1/2 (part), 137/2/1 (part), 140/1, 200/1, 200/2, 200/3, 201, 202/1, 202/2, 202/3, 202/4, 202/5, 202/6, 202/7, 203/3/1 (part), 206/2 (part), 203/2/1, 203/4/1, 213/1, 213/2, 203/4/2, 206/1 (part), 211, 212, 210/4, 210/3, 210/1, 210/2, 280/1 (part), 281/4/1 (part), 281/3/1 (part) of the Government Survey Plan No. LVIII.6, more particularly defined as the areas coloured blue on the Survey Plan Serial No. 3653 deposited with the Headquarters of the Sovereign Base Area Administration at Episkopi.
