THE BRITISH NATIONALITY (OFFENCES AND FEES)  
ORDINANCE

(Cap. 106—Laws of Cyprus).

REGULATIONS MADE BY THE ADMINISTRATOR  
UNDER SECTION 4.

---

In exercise of the powers conferred upon him by Section 4 of the British Nationality (Offences and Fees) Ordinance, the Administrator hereby makes the following Regulations:

1.—(1) These Regulations may be cited as the British Nationality (Sovereign Base Areas) (Fees) Regulations, 1982 and shall come into operation on 1st of January, 1983.

(2) In these Regulations “the Act” means the British Nationality Act 1981; and, unless the context otherwise requires, any reference to a section or Schedule shall be construed as a reference to a section contained in that Act or, as the case may be, to a Schedule to that Act.

2.—(1) Subject to the provisions of this Regulation, the fees specified in the Schedule to these Regulations may be taken in respect of things done in the Sovereign Base Areas of Akrotiri and Dhekelia under the Act and shall be applied in the manner set out in the said Schedule.

(2) The fee payable in respect of—

- (a) the registration of a person as a British Dependent Territories citizen; or
- (b) the grant to a person of a certificate of naturalisation as a British Dependent Territories citizen: or
- (c) the registration of a declaration of renunciation of British Dependent Territories citizenship status,

shall be payable on the submission of the application for such registration or such a certificate or, as the case may be, of the declaration of renunciation.

(3) Where a husband and wife apply at the same time for the grant of certificates of naturalisation as British Dependent Territories citizens and are residing together at the time of the applications, the total fee payable in respect of the certificate shall be £C227.

(4) Where an application is made under any provision of the Act to which item 2 or 4 in the Schedule to these Regulations relates for the registration of a minor as a British Dependent Territories citizen at the same time as an application or applications under the same or any other such provision for the registration of some other minor or minors having the same parent, the total fee payable in respect of the registrations shall be £C29.500 unless each application is made under a

provision to which the said item 4 relates, in which case the total fee payable shall be £C8.500. In this paragraph "parent" includes a step-parent and an adoptive parent.

(5) Where a declaration of renunciation of British Dependent Territories citizenship status is made by a person at the same time as a declaration of renunciation by him of another such citizenship or status, the total fee payable in respect of the registration of the declaration shall be £C29.500.

3. The British Nationality (Fees) Regulations, 1962 are hereby revoked.
