THE IMMOVABLE PROPERTY (TENURE,
REGISTRATION AND VALUATION) ORDINANCE

(Cap. 224 and Law 3 of 1960 — Laws of Cyprus —
and Ordinance 12 of 1966).

SUBSTITUTION OF USE OF COMMUNAL PROPERTY
UNDER SECTION 19(d).

In exercise of the powers vested in him by paragraph (d) of Section 19 of the Immovable Property (Tenure, Registration and Valuation) Ordinance, the Administrator has been pleased to terminate the use of the area described in the Schedule hereto of the communal property held or enjoyed by the Zakaki quarter of Limassol, in so far as the communal property in question lies within the Akrotiri Sovereign Base Area, as a quarrying ground and has further been pleased to substitute for such use, in respect of the said area the following use, that is to say, the said area to be used as a public football ground, as authorized by at least two-thirds of the male inhabitants of the said quarter who have attained the age of twenty one years, provided that any proceeds or revenue accruing to the community from the said public football ground shall be administered by the Village Authority of Zakaki and spent for communal purposes within the quarter subject to the approval of the appropriate Republican authorities.

S C H E D U L E

All that area of land situated at Zakaki quarter of Limassol town, in so far as that land lies in the Akrotiri Sovereign Base Area, being part of the Zakaki Merra and more particularly defined on a plan held at the Area Office Akrotiri.

THE COURTS ORDINANCE

RULES OF COURT MADE BY THE ADMINISTRATOR
UNDER SECTION 63.

In exercise of the powers vested in him by Section 63 of the Courts Ordinance, 1960, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Rules of Court :—

1. These Rules may be cited as the Civil Procedure (Amendment) Rules, 1983 and shall be read as one with the Civil Procedure Rules, as amended from time to time (hereinafter referred to “as the principal Rules”).
