**THE COMMODITIES AND SERVICES
(REGULATION AND CONTROL) ORDINANCE, 1962.**

(Ordinances 11 of 1962, 9 of 1963, 3 of 1967,
10 of 1972 and 10 of 1982).

**CONTROL AND MAXIMUM PRICE ORDER
MADE UNDER SECTIONS 3(1) AND 4(1).**

In exercise of the powers vested in him by subsection (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, 1962 the Administrator hereby makes the following Order:-

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Pasteurised and/or Homogenised Fresh Cow's Milk) (Amendment) Order, 1993 and shall be read as one with the Commodities and Services (Regulation and Control) (Maximum Price of Pasteurised and/or Homogenised Fresh Cow's Milk) Order, 1975 as amended from time to time (hereinafter referred to as "the principal Order.").

2. The principal Order is hereby amended by deleting the Schedule thereto and substituting therefor the following new Schedule:-

3. Public Instrument No.20 of 1992 is hereby revoked.
