THE LAND ACQUISITION ORDINANCE

(Cap.226 - Laws of Cyprus - and Ordinances 12 of 1963, 9 of 1964,
1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993).

NOTICE UNDER SECTION 6.

With reference to Notice under Sections 2, 3 and 5 of the above Ordinance published as Public Instrument No. 5 in Supplement No.3 to the Gazette No. 1012 of 21 January, 1994 notice is hereby given that easements, privileges and liberties and rights to restrict the owner from erecting or installing any building or structure or from planting any trees over, through, or within a distance of two metres either side of the pipeline in the land referred to in the Schedule to this Notice are required to be created and acquired for the undertaking of the public utility mentioned therein as follows:-

2. For the purpose of the laying, using and maintaining of a water pipe line (including the provision of a valve and/or other chambers (hereinafter referred to as "valve chambers" and marker beacons) in, over or under the plots of land referred to in the Schedule to this Notice the route of which is more particularly defined as the line coloured red on the plan deposited with the Department of Lands and Surveys dated the Twelfth day of January 1994.

3. Any person claiming to have any right or interest in the said land who objects to the creation and acquisition of the said easements, privileges and liberties, is required within twenty one days from the date of the publication of this notice to send me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

4. The Administrator is willing to treat for the acquisition of the said easements, privileges and liberties.

5. The plans mentioned above are available for inspection at the office of the Area Officer Akrotiri.

6. The period mentioned in paragraph 3 hereof has been abridged to ten days with the approval of the Administrator.
