**THE LAND ACQUISITION ORDINANCE**

(Cap. 226 - Laws of Cyprus - and Ordinances 12 of 1963, 9 of 1964,  
1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993)

**NOTICE UNDER SECTION 6.**

With reference to Public Instrument No. 64 of 1994 published in Supplement No. 3 to the Gazette No. 1031 of the 27th September, 1994, notice is hereby given that the following immovable property is required for the undertaking of the public utility mentioned therein.

2. The private immovable property within the Akrotiri Sovereign Base Area in the villages of :-

- (a) Episkopi village under and in connection with Plot No. 73 (part) of the Government Survey Plan LVIII.13.
- (b) Akrotiri village under and in connection with Plot Nos. 124/2 (part) of the Government Survey Plan LVIII.21, 4(part), 30/1 (part) of the Government Survey Plan LVIII.22, 1/1 (part) of the Government Survey Plan LVIII.38.

3. The land area of the above immovable properties comprises 2 decares and 200 square metres or thereabouts and is coloured red on the relative set of plans signed by the Area Officer, Akrotiri and dated 11th October 1994.

4. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within twenty-one days from the date of publication of this notice, to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

5. The Administrator is willing to treat for the acquisition of the said land.

6. A set of plans showing the land described above, is available for inspection at the Area Office, Phassouri, Sovereign Base Area, Akrotiri.

**THE CHILDREN ORDINANCE**  
**Cap. 352 - (Laws of Cyprus).**

**ORDER UNDER SECTION 29 (4).**

In exercise of the powers conferred upon him under subsection (4) of Section 29 of the Children Ordinance, the Chief Officer hereby makes the following Order:-

1. This Order may be cited as the Children (Nurseries) (Amendment) Order, 1994 and shall be read as one with the Children (Nurseries) Order, 1994 (hereinafter referred to as "the principal Order").

P.I.No.44/94.

2. Paragraph 4 of the principal Order is hereby amended by deleting sub-paragraph (3) thereof and substituting therefor the following new sub-paragraph:-

"(3) During the time when the Nursery is in operation, staff shall be employed therein in the following proportion in relation to the number of children:

- (a) One nursery assistant for a maximum number of 28 children aged 4 years and over;
- (b) one nursery assistant for a maximum number of 24 children aged 3 years;
- (c) one nursery assistant for a maximum number of 15 children aged 2 years;
- (d) one nursery assistant for a maximum number of 6 infants not exceeding the age of 2 years."

3. Paragraph 8 of the principal order is hereby repealed and replaced by the following new paragraph 8.

"8. The person in charge of the Nursery shall bear the exclusive responsibility for the management and supervision of the work carried out thereat and for this reason such person must be present at the Nursery during the majority of the time when this is in operation."

4. Paragraph 12 of the principal Order is hereby amended by deleting the words "at least 3 feet" appearing in the 3rd and 4th lines thereof and substituting therefor the words "at least ninety centimetres."
