THE LAND ACQUISITION ORDINANCE

(Cap. 226 - Laws of Cyprus - and Ordinances 12 of 1963, 9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993)

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 82 of 1994 published in Supplement No. 3 to the Gazette No. 1038 of the 22nd December, 1994, notice is hereby given that the following immovable property is required for the undertaking of the public utility mentioned therein:-

To construct an access road and provide other facilities in connection with the undertaking of public utility above mentioned, in, over or under the following privately-owned immovable property within the Sovereign Base Area of Dhekelia, in the village of Ormidhia (Larnaca District), under and in connection with plot numbers 27/5 (part), 26/1 (part), 26/2 (part) of the Government Survey Plan XL.I.21.E2.

2. The land area of the above immovable properties comprises 1 decare and 440 square metres or thereabouts and is coloured red on the relative plan kept at the Office of the Sovereign Base Areas Administration of Dhekelia and dated 1 March, 1995.

3. Any person claiming to have any right or interest in the said land, who objects to the acquisition, is required within six weeks from the date of publication of this notice, to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

4. The Administrator is willing to treat for the acquisition of the said land.

5. The plan showing the land described above, is available for inspection at the Office of the Sovereign Base Areas Administration of Dhekelia.

THE GAME AND WILD BIRDS (PROTECTION AND
DEVELOPMENT) ORDINANCE, 1974

(Ordinances 11 of 1974, 1 of 1982, 3 of 1985 9 of 1988,
20 of 1989, 13 of 1991 and 15 of 1993).

SPECIAL PERMIT ISSUED UNDER SECTION 21.

In exercise of the powers conferred upon me under Section 21 of the Game and Wild Birds (Protection and Development) Ordinance, 1974, I, the Chief Officer, hereby authorise Mr. Savvas Savva of the Game and Fauna Service of the District Administration, Limassol, to catch hares in the Bishop's Farm area, Akrotiri at Livadhi area and at Paramali - Evdhimou Game Reserve area for the purpose stipulated in the said Section.

2. This permit is issued subject to the following conditions :-
- (a) The number of hares shall not exceed 20.
 - (b) Every operation shall be under the direct and personal supervision of the SBA Forest Guards.
 - (c) The SBA Police and the Royal Air Force Police or Royal Military Police shall be given advance information regarding the date and time of every operation.
3. This permit shall be valid until the 31st August, 1995.
