**THE CONTROL (ENTRY, SETTLEMENT AND
COMMERCIAL ENTERPRISES) ORDINANCE**

(Ordinances 5 of 1960, 5 of 1971 and 11 of 1982).

REGULATIONS MADE UNDER SECTION 23.

In exercise of the powers vested in him by section 23 of the Control (Entry, Settlement and Commercial Enterprises) Ordinance, the Administrator hereby makes the following Regulations:-

1. These Regulations may be cited as the Control (Entry, Settlement and Commercial Enterprises) (Business Licences) (Amendment) Regulations 1998 and shall be read as one with the Control (Entry, Settlement and Commercial Enterprises) (Business Licences) Regulations 1960 as amended from time to time (hereinafter referred to as "the principal Regulations").

2. The principal Regulations are hereby amended by repealing the First Schedule thereof and substituting therefor the following:-
