**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC  
OF CYPRUS) (CONSOLIDATION) ORDINANCE 1976  
(Ordinance 4 of 1976).**

**ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.**

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance 1976 and all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Special Provisions) (Consolidation) (Amendment) Order 2001 and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) (Special Provisions) (Consolidation) Order 1982 as amended from time to time (hereinafter referred to as "the principal Order").
