THE AKROTIRI COMMUNITY ORDINANCE
(Ordinances 23 of 2001 and 24 of 2001)

NOTICE UNDER SECTION 100.

NOTICE is hereby given that the following immovable property, namely the private immovable property within the Sovereign Base Area of Akrotiri, in the village of Akrotiri, under and in connection with plot no. 163 (part) of the Government Survey Plan LVIII/47, comprising 295 square metres or thereabouts of land and shown coloured red on a relevant plan under identification number N18/243396, signed by the Director of the Land Registry and Survey Department of the Republic of Cyprus on the 3rd day of December 2002 and deposited at the Area Office of Akrotiri, is required by the Council of the Akrotiri Community for the purpose of constructing, improving, tarmacking and developing Akropoleos Street, in the village of Akrotiri, within the Sovereign Base Area of Akrotiri.

Any person claiming to have any right or interest in the said immovable property, who objects to the acquisition of such property, is required within six weeks from the date of the posting of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Council of the aforesaid community is willing to treat for the acquisition of the said immovable property.

The plan showing the immovable property described above is available for inspection at the Area Office Akrotiri.

**THE SUPPLIES AND SERVICES
(TRANSITIONAL POWERS) (CYPRUS) ORDER 1946.**

**ORDER MADE BY THE COMPETENT AUTHORITY
UNDER DEFENCE REGULATION 63.**

In exercise of the powers vested in him by Defence Regulation 63, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order 1946, (as applied to and adapted in the Sovereign Base Areas of Akrotiri and Dhekelia by the Sovereign Base Areas of Akrotiri and Dhekelia Order in Council, 1960, and the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance, 1968), which Order continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Ordinance, the Competent Authority, for the purpose of the said Regulation, hereby makes the following Order:-

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for the purpose of constructing, improving and developing public roads within the Sovereign Base Area of Akrotiri, of the land and property specified in the Second Schedule hereto (hereinafter referred to as "the land") during a period of one year as from the date of this Order, is hereby authorised.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for the purposes referred to in paragraph 1 of this Order.

3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of any interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE

1. The land shall be occupied and used for the purpose of constructing, improving, tarmacking and developing Akropoleos Street, in the village of Akrotiri, within the Sovereign Base Area of Akrotiri.

2. At the expiration of this Order the part of the land which shall not have been compulsorily acquired by an Order made under Section 100 of the Akrotiri Community Council Ordinance 2001, shall be returned to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of this Order.

3. Compensation shall be paid to the persons having an interest in the land for its use and occupation under this Order.

SECOND SCHEDULE

1. The private immovable property within the Sovereign Base Area of Akrotiri, in the village of Akrotiri under and in connection with plot no. 163 (part) of the Government Survey Plan LVIII/47.

2. The land area of the above immovable property comprises 295 square metres or thereabouts and is shown coloured red on a plan under identification number N18/243396, signed by the Director of the Land Registry and Survey Department of the Republic of Cyprus on the 3rd day of December 2002 and kept at the Headquarters of the Sovereign Base Areas Administration.
