### NOTICE UNDER SECTION 6

Any person claiming to have any right or interest in the said land, who objects to the acquisition referred to in this notice, is required, within thirty days from the date of promulgation of this notice, to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

4. The Administrator is willing to treat for the acquisition of the said immovable property.

5. A set of plans, showing the land described above, is available for inspection at the Area Office, Akrotiri Sovereign Base Area.
