**EMPLOYEES AT PLACES OF ENTERTAINMENT (TERMS OF EMPLOYMENT)
REGULATIONS 2010**

The Administrator makes these Regulations in exercise of the powers under section 3 of the Employees at Places of Entertainment (Terms of Employment) Ordinance 2002(a) and under section 28A of the Interpretation Ordinance(b).

Citation and Commencement

1. These Regulations may be cited as the Employees at Places of Entertainment (Terms of Employment) Regulations 2010 and come into force on the day that they are published in the Gazette.

Adoption of Republican Regulations

2. The following Republican instruments have effect in the Areas (so far as relevant) as if they are made under section 3 of the Employees at Places of Entertainment (Terms of Employment) Ordinance 2002 —

- (a) the Employees at Places of Entertainment (Terms of Employment) Regulations 1968(c),
- (b) the Employees at Places of Entertainment (Terms of Employment)(Amendment) Regulations 1978(d), and
- (c) the Employees at Places of Entertainment (Terms of Employment) (Amendment) Regulations 2009(e).

Revocation of the Employees at Places of Entertainment (Terms of Employment) Regulations 2003

3. The Employees at Places of Entertainment (Terms of Employment) Regulations 2003(f) are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

Introduction

1. This explanatory note relates to the Employees at Places of Entertainment (Terms of Employment) Regulations 2010 (“the Regulations”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Regulations. It does not form part of the Regulations.

2. The note should be read in conjunction with the Regulations. It is not, and is not meant to be, a comprehensive description of the Regulations.

Particular points

3. Section 28A of the Interpretation Ordinance (as amended by Ordinance 37/03 and by Ordinance 16/10) provides that a power to make a public instrument includes a power to specify that the whole or part of a Republican public instrument is to have effect in the Areas subject to any specified exceptions, adaptations or modifications. Once it is specified that a Republican public instrument is to have effect in the Areas, that public instrument is an adopted instrument within the Adopted Instruments Ordinance 2003 (Ordinance 15/03 as amended by Ordinance 36/03 and Ordinance 17/10). The Adopted Instruments Ordinance 2003 sets out the consequences of adoption. For example, powers and duties conferred by the Republican Regulations on Republican officers are conferred on the Chief Officer and delegated to the Republic. Another consequence is that the SBA Court can take judicial notice of the Republican Regulations.

4. The Regulations provide for the adoption in the Areas of three sets of Republican Regulations made under the Employees at Places of Entertainment (Terms of Employment) Law of the Republic. The Regulations also revoke the Employees at Places of Entertainment (Terms of Employment) Regulations 2003.
