**FISH FARMING (ADOPTION OF PUBLIC INSTRUMENTS OF THE REPUBLIC)  
REGULATIONS 2012**

---

The Administrator makes the following Regulations in exercise of the powers in section 23 of the Fish Farming Ordinance 2001(a).

**Citation**

1. These Regulations may be cited as the Fish Farming (Adoption of Public Instruments of the Republic) Regulations 2012.

**Commencement**

2. These Regulations come into force on 1 July 2012.

**Public instruments of the Republic have effect in the Areas**

3. (1) The public instruments of the Republic referred to in paragraph (2) have effect in the Areas as if they had been made under section 23 of the Fish Farming Ordinance 2001, so far as relevant and subject to all necessary modifications and to paragraph (3).

(2) The public instruments are—

- (a) public instrument 533 of 2002(b);
- (b) public instrument 911 of 2003(c);
- (c) public instrument 248 of 2010(d).

(3) Regulation 14 of public instrument 533 of 2002 does not have effect in the Areas.

**Fish Farming (General) Regulations 2004 revoked**

4. The Fish Farming (General) Regulations 2004(e) are revoked.

## EXPLANATORY NOTE

### (This note does not form part of the Regulations)

1. This explanatory note relates to the Fish Farming (Adoption of Public Instruments of the Republic) Regulations 2012 (the “Regulations”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader. The note should be read in conjunction with the Regulations.
2. The Regulations revoke and re-enact, with amendments, the Fish Farming (General) Regulations 2004, which provided for two public instruments (No. 533 of 2002 and No. 911 of 2003) made under the Republic of Cyprus law 117(I)/2000 (the equivalent in the Republic of the Fish Farming Ordinance 2001) to have effect in the Areas as if made under that Ordinance. The Adopted Instruments Ordinance 2003 makes provision for the interpretation, etc. of adopted legislation.
3. Regulation 3 provides for a further public instrument of the Republic (No. 248 of 2010) to have effect in the Areas. This instrument amends the existing public instruments in relation to *inter alia* fees, and prescribes application forms.
4. Regulation 3(3) provides that regulation 14 of Republic of Cyprus public instrument No. 533 of 2002 does not have effect in the Areas. Section 18ZA of the Fish Farming Ordinance 2001 now contains the criminal offences created by regulation 14, so it is unnecessary for that regulation to continue to have effect.
