BIRTHS, STILL-BIRTHS AND DEATHS REGISTRATION (PRESCRIPTION OF FORMS) (AMENDMENT) REGULATIONS 2013

The Administrator makes these Regulations in exercise of the powers in section 45 of the Births and Deaths Registration Ordinance 1975(a):

Citation

1. These Regulations may be cited as the Births, Still-births and Deaths Registration (Prescription of Forms) (Amendment) Regulations 2013.

Commencement

2. These Regulations come into force on 1 October 2013.

Births, Still-births and Deaths Registration (Prescription of Forms) Regulations 1975 amended

3. The Births, Still-births and Deaths Registration (Prescription of Forms) Regulations 1975(b) are amended in accordance with regulations 4 to 9.

Regulation 3 (notice to informant to give information)

4. Regulation 3 is amended by omitting “sections 7, 10 and 22” and substituting “sections 7 and 22”.

Regulation 9 revoked

5. Regulation 9 is revoked.

Regulation 11 amended (birth certificate)

6. Regulation 11 is amended by omitting “Form 8A” and substituting “Form 10”.

Regulation 20 amended (certificate that registration of a death in the Areas is not required)

7. Regulation 20 is amended by omitting “, and a fee of fifty mils shall be payable for the issue of such a certificate”.

Regulations 23 and 24 revoked

8. Regulations 23 and 24 are revoked.

Schedule amended

9. (1) The Schedule is amended in accordance with this regulation.
- (2) Form 2 is amended by—
- (a) omitting “Sections 7, 10 and 22” and substituting “Sections 7 and 22”;
 - (b) omitting “Superintendent Registrar”.
- (3) Form 9 is amended by omitting “FEE PAID: 50 mils”.
- (4) Form 10 is amended by omitting in both places “150 mils”.

- (5) Form 11 is amended by—
 - (a) omitting “19”; and
 - (b) omitting “50 mils”.
- (6) Form 12 is amended by—
 - (a) omitting in both places “19”; and
 - (b) omitting “50 mils”.
- (7) Form 20 is amended by omitting “50 mils”.
- (8) Form 21 is omitted.
- (9) Form 22 is amended by omitting in both places “150 mils”.

EXPLANATORY NOTE

(This note does not form part of the Regulations)

1. This explanatory note relates to the Births, Still-births and Deaths Registration (Prescription of Forms) (Amendment) Regulations 2013 (the “Regulations”). It has been prepared by the Office of the Attorney-General and Legal Adviser in order to assist the reader of the Regulations.
2. The Regulations amend the Births, Still-births and Deaths Registration (Prescription of Forms) Regulations 1975 (the “principal Regulations”) in a number of minor respects, largely consequent upon the amendments made to the Births and Deaths Registration Ordinance 1975 by the Births and Deaths Registration (Amendment) Ordinance 2013. In particular, all references to fees in the principal Regulations are removed.
