FISHERIES (AMENDMENT NO. 3) REGULATIONS 2013

The Administrator makes the following Regulations in exercise of the powers in section 40 of the Fisheries Ordinance 2012(a).

Citation

1. These Regulations may be cited as the Fisheries (Amendment No. 3) Regulations 2013.

Commencement

2. These Regulations come into force on 1 December 2013.

Fisheries Regulations 2012 amended

3. The Fisheries Regulations 2012(b) are amended in accordance with regulation 4.

Regulation 11 amended (Akrotiri fish reserve)

4. Regulation 11(2) is revoked and the following paragraph substituted—

“(2) In this regulation, “Akrotiri fish reserve” means that part of the sea, the surface area of which is bounded by—

- (a) the line joining the position latitude 34° 34.746' N, longitude 33° 01.615' E (“point A”) to the position latitude 34° 34.825' N, longitude 33° 01.824' E (“point B”);
- (b) the line joining point B to the position latitude 34° 34.442' N, longitude 33° 01.872' E (“point C”); and
- (c) the coastline between point C and point A.”

Fisheries (Amendment) Regulations 2013 revoked

5. The Fisheries (Amendment) Regulations 2013(c) are revoked.

EXPLANATORY NOTE

(This note does not form part of the Regulations)

1. This explanatory note relates to the Fisheries (Amendment No. 3) Regulations 2013 (the “Regulations”). It has been prepared by the Office of the Attorney-General and Legal Adviser in order to assist the reader.
2. The Regulations amend the Fisheries Regulations 2012 (the “principal Regulations”).
3. Regulation 11 of the principal Regulations is amended to reduce the area of the Akrotiri fish reserve. It is an offence to fish in the Akrotiri fish reserve (see regulations 11 and 53 of the principal Regulations).
4. The Fisheries (Amendment) Regulations 2013 are revoked.

**EXPORT OF CURRENCY (RESTRICTIVE MEASURES) (CONTINUATION) (NO. 10)
ORDER 2013**

The Chief Officer makes the following Order in exercise of the powers in section 2(3) of the Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013(a).

Citation

1. This Order may be cited as the Export of Currency (Restrictive Measures) (Continuation) (No. 10) Order 2013.

Commencement

2. This Order comes into force at 11.59 pm on 30 November 2013.

Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force

3. The Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force and expires at the end of 31 January 2014.

Export of Currency (Restrictive Measures) (Continuation) (No. 9) Order 2013 revoked

4. The Export of Currency (Restrictive Measures) (Continuation) (No. 9) Order 2013(b) is revoked.
