2. This Order applies to the land listed on the Schedule and marked in red on a plan labelled 58/04 which is available for inspection at the Area Office Akrotiri during normal working hours.

Sanction of acquisition



EXPLANATORY NOTE

(This note is not part of the Order)

- **1.** This explanatory note relates to the Land Acquisition (Extension of Curium Antiquity Site) Order 2024 (the "Order"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order.
- **2.** The Order is made under the Land Acquisition Ordinance (Cap.226), which sets out the statutory framework for the compulsory acquisition of land required for an "undertaking of public utility".
- **3.** The Order relates the compulsory acquisition of land required for the extension of Curium Antiquity Site. The Order sanctions the acquisition of the land.
