**Immovable Property (Tenure, Registration and Valuation) Ordinance (Cap.224)**

Notification of general valuation.

By way of public instrument number 07 of 2019 (published in the Gazette on 12 July 2019, the Administrator ordered a general valuation of all immovable property in the Sovereign Base Areas.

In exercise of the powers conferred upon me by section 70(1)(a) of the Immovable Property (Tenure, Registration and Valuation) Ordinance (Cap 224), I notify the public that the general valuation of immovable property in the Areas, on the basis of the prices prevailing on 1 January 2018, begins on the date of publication of this notification Gazette.

I invite all owners of immovable property located in the Areas to—

- (a) provide the valuer with such information, orally or in writing, in relation to the immovable property under valuation, upon the valuer's request;
- (b) furnish to the valuer for inspection, any document that they hold or control and which relates to the immovable property under valuation, upon the valuer's request.
